**SEC Online™** is a full-text database of reports filed by public companies with the U.S. Securities and Exchange Commission. All companies on the New York and American Stock Exchanges, as well as over 2,000 NASDAQ National Market Share companies, are included in the SEC ONLINE database, which contains the actual, unedited text of these companies' 10-K's, 10-Q's, 20-F's, Annual Reports and Proxy Statements, including any amendments to them.

**SUBJECT COVERAGE**

The **SEC ONLINE** database provides the following documents, as filed with the Securities and Exchange Commission:

**File 541:**

- Annual Report: Not required to be filed with the SEC. The Annual Report is a report to shareholders which discloses corporate information and includes an opening letter from the Chief Executive Officer summarizing results of the prior year and the forecast and outlook for the upcoming fiscal year.

**File 542:**

- Form 10-K: Official annual report filed by U.S. public companies within 90 days after fiscal year-end.
- Form 20-F: Official annual report filed by non-U.S., non-Canadian registrants within 6 months after the fiscal year-end.

**File 543:**

- Form 10-Q: Official quarterly report filed within 45 days after the close of each quarter.

**File 544:**

- Proxy Statement: Official report/notification to shareholders of shareholder meetings and issues to be voted upon.

**SOURCES**

The sources for SEC Online information are the documents filed with the Securities and Exchange Commission.

	Knight-Ridder, Inc., is an international information and communications company engaged in newspaper publishing, business news and information services, electronic retrieval services, news, graphic and photo services, cable television and newsprint manufacturing. Knight Ridder has various information services reach more than 100 million people in 129 countries.
	History
	The Knight group of newspapers, was begun in 1903 when Charles Landon Knight purchased the Akron Beacon Journal. The Ridder group of newspapers started in 1892 when Herman Ridder acquired German-language Staats-Zeitung in New York. Both groups flourished each taking its stock public in 1969. In 1974, Knight Newspapers, and Ridder Publications, Inc., merged to form a national company with operations coast to coast.
	The Business Information Services Division was formally established in 1983 with the Journal of Commerce and Commodity News Services.

	Knight-Ridder's 10 long-term goals, approved by the Board of Directors in December 1989, are:

KRI Stock

Knight-Ridder common stock is listed on the New York Stock Exchange under the symbol KRI and on the Tokyo Stock Exchange with the designation 9491. The stock is also traded on exchanges in Philadelphia, Chicago, Boston, San Francisco, Los Angeles and Cincinnati, as well as through the Intermarket Trading System. Options are traded on the Philadelphia Exchange.

Knight-Ridder stock split two-for-one in 1978 and 1983 Knight Newspapers, Inc., had a two-for-one split in 1972.

The company's 51.4 million shares are held in all 50 states by approximately 11,200 shareholders of record.

Headquarters/Employees

The company is headquartered in Miami, Fla., and employs more than 21,000 people.
